# Regular Session Board Meeting Highlights August 6, 2020

The Gates County Board of Education met in a regular session on Thursday, August 6, 2020, through a remote meeting using the Zoom format. This was agreed to by the board members in order to comply with the Governor's Order regarding the Coronavirus Pandemic. Chairman Ray Felton called the meeting to order at 9:00 a.m. The following board members were present: Mr. Ray Felton, Mrs. Glendale Boone, Mr. Leslie Byrum, Mrs. Sallie Ryan, and Mrs. Amanda Pacitto.

Mr. Leslie Byrum made a motion to enter into closed session to discuss personnel as outlined in North Carolina General Statute 143-318.11(a)(6). Mrs. Sallie Ryan seconded the motion. Chairman Felton called for a vote. Board members stated their name and their vote, and the motion carried unanimously. The board entered closed session at 9:02 a.m.

The board reconvened open session at 10:01 a.m. with all board members present.

Mr. Leslie Byrum made a motion to amend the agenda by adding the discussion of Pre-K students participating in face-to-face instruction, and to approve the agenda with the addition. Mrs. Glendale Boone seconded the motion. Chairman Felton called for a vote. Board members stated their name and their vote, and the motion was unanimously approved.

Mrs. Amanda Pacitto noted that she may have to leave the meeting, if it goes beyond 11:15, due to a previous appointment.

There was a moment of silence, followed by the Pledge of Allegiance.

There were no public comments.

Superintendent Report: Dr. Williams participated in a North Carolina Association of School Administrators (NCASA) zoom meeting, with other Superintendents, this morning, and he noted some points from the meeting

## **Board Report:**

• Mrs. Sallie Ryan reported on the July 27, 2020 Race & Equity Meeting, where the following goals were set:

Advocate for equitable learning opportunities Address matters of disproportionality Collaborate with schools and staff to develop Survey students and staff yearly on equity issues Review racial and equity plans currently in use

Mrs. Sandra Pittman, Finance Officer, requested that the out-of-district tuition cost for 2020-2021 remain at \$1750.00 per student per year. Mrs. Glendale Boone made a motion to add this as Item No. Fifteen to the Consent Agenda. Mrs. Amanda Pacitto seconded the motion. Chairman Felton called for a vote. Board Members stated their name and their vote. The motion passed unanimously. The board requested a contract be prepared for out-of-district parents to sign, that states the terms regarding tuition payments, and requires the principal signature. We also need to have a plan in place for students that are released to other counties; should they want to return to Gates County Schools.

Mrs. Pittman had provided monthly reports to the board prior to the meeting. We still do not have a state budget. Some past due tuition payments have been collected, but the uncollected amount is still high. State Funding for 2020-2021 will possibly be cut by approximately \$250,000, and Local Funding for 2020-2021 will be \$50,000 less than last year. The audit should be completed by 10-31-2020.

### **Discussion- Pre-K Face-to-Face Instruction**

Mrs. Jordan has received information that strongly encourages face-to-face instruction for Pre-K students. There is a possibility that we will lose some funding if we do not provide face-to-face instruction. We have six special needs students in the Pre-K program that would qualify for face-to-face instruction during the first nine weeks of remote learning. Board members had concerns with allowing Pre-K students to come to school and not allowing kindergarten students.

Mrs. Ryan made a motion to table this discussion until Mrs. Jordan can research the funding issue. The six Pre-K special needs students will be allowed to attend. The motion was seconded by Mr. Leslie Byrum. Chairman Felton called for a vote. Board members stated their name and their vote, and the motion passed unanimously.
