# Regular Session Board Meeting Highlights September 9, 2019

The Gates County Board of Education met in regular session on Monday, September 9, 2019, at the Board of Education Central Office. Chairman Ray Felton called the meeting to order at 3:00 p.m. The following board members were present: Mr. Ray Felton, Mrs. Glendale Boone, Mr. Leslie Byrum, Mrs. Claire Whitehurst and Mrs. Sallie Ryan.

Mrs. Boone made a motion to enter into closed session to discuss personnel as outlined in North Carolina General Statute 143-318.11(a)(6). Mrs. Whitehurst seconded the motion. There was no discussion, and the motion carried unanimously.

Mr. Felton reconvened open session at 4:12 p.m., with the following board members present: Mr. Ray Felton, Mrs. Glendale Boone, Mr. Leslie Byrum, Mrs. Claire Whitehurst and Mrs. Sallie Ryan.

Mr. Byrum made a motion to approve the agenda. Mrs. Whitehurst seconded the motion. There was no discussion and the motion carried unanimously.

There was a moment of silence, followed by the Pledge of Allegiance, led by Sarah Powell.

During Public Comments Dawn Powell, Sarah Powell and Jen Cowen spoke about conflict within the Band Boosters organization. There was an incident after the football game on Wednesday, September 4<sup>-</sup> 2019, involving members of the band boosters, which has caused distress for Mrs. Powell and her daughter Sarah. They requested help from the board to resolve this matter. Mr. Felton thanked them for their comments, but indicated that per policy, the board is not allowed to respond to individuals who address the board, except to request clarification of points made by the presenter. He did indicate that the board is concerned about this being a reflection on our school system.

Amanda Hobbs, AIG Coordinator showed a power point of the AIG trip to Belize this past summer. She provided their itinerary and a brief summary of what they did each day. She said the students learned about the culture of the country, and were able to sample local food and participate in their local activities. It was an enjoyable trip for all, and she is looking forward to their trip to Barcelona, Spain in June, 2020.

During the Superintendent's Report, Dr. Williams commented on some traffic problems at Buckland and Central Middle at the beginning of school, but all have been resolved. We have only been in school a short amount of time and already have dealt with fog delays and a hurricane. We are still waiting on a budget from the state.

During the Report from the Board, members commented on the School Open Houses they attended. They were very impressed with the principals, staff, and the amount of parents that attended. Mr. Felton gave an update on the completion of the renovation of the 6<sup>th</sup> and 7<sup>th</sup> grade wings at Central Middle.

Mrs. Sandra Pittman, our new finance officer, provided the July financial report and stated the New Beginnings Daycare Update would be forthcoming.
