Board Meeting Highlights Regular Session January 12, 2018

The Gates County Board of Education met in regular session on Friday, January 12, 2018, at the Gates County Board of Education Central Office. Chairman Felton called the meeting to order at 9:05 a.m. The following board members were present: Ray Felton, Glendale Boone, Leslie Byrum, Claire Whitehurst and Dr. Daniel Dickerson. Mrs. Boone made a motion to go into closed session to discuss personnel as outlined in North Carolina General Statute 143-318.11(a)(6). The motion was seconded by Mrs. Whitehurst, and the board approved the motion unanimously. The Board entered into closed session at 9:05 a.m.

Mr. Felton reconvened open session at 10:11 a.m., with the following board members present: Ray Felton, Glendale Boone, Leslie Byrum, Claire Whitehurst and Dr. Daniel Dickerson.

Mr. Byrum made a motion to amend the agenda by adding Item 4b under Items for Information – Request for Release of Meghan Riddick, from Gates County Schools, to attend Elizabeth City/Pasquotank Public Schools. Mrs. Boone seconded the motion, and the board members approved the motion unanimously.

Mr. Felton welcomed Dr. Shawn Wilson, new principal at Gatesville Elementary School, and Mr. Steve Rogers, parent of Gatesville Elementary School student, to the meeting.

There was a moment of silence followed by the Pledge of Allegiance.

There were no public comments.

During the Superintendent's Report, Dr. Williams informed that there may be some new development on HB13 - Class Size Legislature, but we will have to wait and see what happens. He also indicated that there was a meeting, with staff on January 9, 2018, to begin discussion of the 2018-2019 budget.

In honor of January being School Board Appreciation Month, Dr. Williams presented Years of Service pins to board members that had served 5 or more years. Those receiving pins were as follows:

Dr. Williams introduced Dr. Shawn Wilson, principal at Gatesville Elementary. Dr. Wilson thanked everyone for the opportunity to become part of the Gates County Schools' family. Dr.

Williams also noted that she will be introduced at the PTA meeting at Gatesville Elementary on Tuesday, January 16, 2018 at 6:30 p.m.

Dr. Williams informed that he has been chosen to serve on Governor Ray Cooper's Superintendent Educational Advisory Council, representing the Northeast. He hopes to be able to bring attention to the many challenges that rural schools in the Northeast are facing.

During the Report from the Board, Board Members commented on participation in the Gatesville Christmas Parade. Mr. Felton noted that he serves on the board for Chowan University, and they are preparing to hire a new President. He feels sure that the new President will be offering opportunities at Chowan University, for our students here in Gates County.
