Regular Session Board Meeting March 30, 2018

The Gates County Board of Education met in regular session on Friday, March 30, 2018, at the Gates County Board of Education Central Office. Vice-Chairman Glendale Boone called the meeting to order at 11:00 a.m. The following board members were present: Mrs. Glendale Boone, Mr. Leslie Byrum, Mrs. Claire Whitehurst and Dr. Daniel Dickerson. Mr. Felton was not present. Mrs. Whitehurst made a motion to go into closed session to discuss personnel as allowed by North Carolina General Statute 143-318.11(a)(6). The motion was seconded by Mr. Byrum, and the board approved the motion unanimously. The Board entered into closed session at 11:05 a.m.

Vice-Chairman Boone reconvened open session at 12:03 p.m., with the following board members present: Glendale Boone, Leslie Byrum, Claire Whitehurst, and Dr. Daniel Dickerson.

Mr. Byrum made a motion to approve the agenda. Mrs. Whitehurst seconded the motion, and the board members approved the motion unanimously.

During the Superintendent's Report, Dr. Williams reported that he had received an e-mail from Natalie Rountree, County Manager, informing that we can put Central Middle School construction out for bids. Dr. Williams stated that the county will need to get the Local Government Commission approval before we can proceed. He said he hoped to be able to start demolition of the 8th grade wing this summer. He is going to devise a plan for collecting bricks and other memorabilia that can be distributed to community members. Mr. Byrum asked if there would be a cost for the memorabilia. He stated that funds collected could be used to create a monument to be placed at the school. Mr. Byrum also said that he had been approached by a community member, in regard to plaques being placed at the elementary schools, honoring the renovations made several years ago. Dr. Williams said he would look into this.

During the Board Report, Mrs. Whitehurst commented on the Strategic Plan Committee and Daycare Committee meetings, that she had attended. She complimented Dr. Paula Simpson on her leadership. Mr. Byrum also commented that Mrs. Tammi Ward had done a great job as leader of the Strategic Plan Committee, that he is serving on.
