Regular Session Board Meeting Highlights July 13, 2020

The Gates County Board of Education met in a regular session on Monday, July 13, 2020, through a remote meeting using the Zoom format. This was agreed to by the board members in order to comply with the Governor's Order regarding the Coronavirus Pandemic. Chairman Ray Felton called the meeting to order at 9:06 a.m. The following board members were present: Mr. Ray Felton, Mrs. Glendale Boone, Mr. Leslie Byrum, Mrs. Sallie Ryan, and Mrs. Amanda Pacitto.

The board welcomed Mrs. Pacitto. Mr. Byrum noted that he was using a secure WiFi for the meeting.

Nikki Liles, Director of the Gaining Early Awareness and Readiness for Undergraduate Programs (GEAR UP), provided information about the program:

- Established in 1998 and funded through the US Department of Education
- Work with cohorts of students, starting no later than 7th grade, in middle schools with 50% or more free and reduced lunch
- This is the 4th state grant and will cover years 2019-2026
- Nearly 35,000 participating students and families throughout the state
- \$25.7 million federal support over the seven year grant

Goals:

- 1. Increase academic performance and preparation for postsecondary education
- 2. Increase the rate of high school graduation and participation in postsecondary education
- 3. Increase GEAR UP students' and their families' knowledge of postsecondary education options, preparation and financing

• Critical Areas:

- 1. College Readiness
- 2. Opportunity gaps in math
- 3. STEM
- 4. Disconnect between postsecondary intention and postsecondary enrollment
- 5. Access to college advising resources and financial aid information
- 6. Postsecondary persistence
