Regular Session Board Meeting Highlights August 6, 2018

The Gates County Board of Education met in regular session on Monday August 6, 2018, at the Board of Education Office. Chairman Felton called the meeting to order at 9:05 a.m. Mrs. Claire Whitehurst made a motion to enter into closed session at 9:05 a.m. and Dr. Daniel Dickerson seconded the motion to discuss matters that are confidential by law, including confidential student matters and to approve closed session minutes, pursuant to North Carolina General Statute 143-318.11(a)(1); to confer with the Board Attorney and preserve the attorney/client privilege as allowed by North Carolina General Statute 143-318.11(a)(3); and to discuss personnel as allowed by North Carolina General Statute 143-318.11(a)(6). There was no discussion and the motion carried unanimously. The following board members were present: Mr. Ray Felton, (Chair), Mrs. Claire Whitehurst, Dr. Daniel Dickerson and Mrs. Glendale Boone. Mrs. Chante' Jordan, HR Director & Board attorney, John Leidy were present.

Mr. Felton reconvened open session at 10:16 a.m. with the following board members present: Mr. Ray Felton, Mrs. Glendale Boone, Mrs. Claire Whitehurst and Dr. Daniel Dickerson.

Mrs. Boone made a motion to approve the agenda. Mrs. Whitehurst seconded the motion, and the board members approved the motion unanimously.

There was a moment of silence, followed by the Pledge of Allegiance.

There were no public comments.

Dr. Landon Mason, Economic Improvement Council Director, spoke about the importance of the Head Start Program. This program is vital in preparing students for kindergarten. The program is facing challenges due to funding, and they are requesting they be allowed to use the space at Gatesville Elementary School, without the payment of rent. He believes that if we enter into this partnership with EIC, that it will send a positive message to the community.

Mr. Felton provided information regarding the 2017 NC Education Lottery Funds received by some of the counties in North Carolina. Gates County received far less than some other counties, and therefore we are facing our own challenges regarding funding. However, they would take the request under consideration. Dr. Mason indicated that he understands what we are facing, since he serves some of the poorest counties in the state.

Dr. Dickerson questioned how their funding was generated. Dr. Mason answered that 20% is provided by federal grants and they are required to provide a 20% In-Kind Match. Dr. Dickerson asked if they normally had trouble meeting the 20% match. Dr. Mason said it has become more difficult, and if they don't meet the match, they have to request a waiver or pay back the 20%. Dr. Mason indicated that Mrs. Lori Ward has been instrumental in making sure the Head Start Program is a success. He said he felt it was important to make the board aware of the challenges they are facing, and that is why he asked to speak at the board meeting today. Mrs. Whitehurst asked how Mrs. Ward helped with the program, and Dr. Mason answered that she helps to prevent dual enrollment in Pre-K and Headstart.

Todd Boyette and Crystal Harden from the Morehead Planetarium presented a powerpoint providing information about the Planetarium and the programs they offer. The Saunders Science Scholars is a new program they are offering to Gates County Schools, in honor of Benjamin Saunders, long-time principal of T.S. Cooper Elementary School. This program will provide students, along with their parents, opportunities that have not been available in the past. There will also be opportunities for the community as well. Family applications will be available at each of the schools' open houses. The student criteria for this program, is an interest in science and adult support. The applications will be reviewed, and interviews will be scheduled.

Benjamin Saunders, Jr. thanked Mr. Boyette and Ms. Harden for their support of this program and the honor of naming it after his father. He also thanked Mr. Butts who donated funds for this program. He said his dad was not able to be at the meeting due to his health, but is very appreciative of this honor.

Amanda Hobbs, District AIG Coordinator, provided a powerpoint with information regarding a trip to Belize for AIG students. Gates County will partner with Elizabeth City Middle School in order to keep the cost down. This trip is sponsored by EF Educational Tours, who have been providing school tours for many years. Mrs. Hobbs said she has students that have already signed up for the trip, which will be in the summer of 2019. Mrs. Hobbs will provide information to students at the beginning of school.

Dr. Paula Simpson noted that the Triennial Assessment of Student Wellness Report was created using the Healthy Active Children's Survey. The board questioned if there were areas of concern. Dr. Simpson said the area she felt needed attention, was Community Involvement.

During the Superintendent's Report, Dr. Williams reported that preparations are being made to remove the asbestos at Central Middle School. Once this is complete, demolition can begin. The target date for the completion of the project is January, 2020, barring unforeseen problems. He reported that Gates County Schools has received a grant to provide Resource Officers. He thanked Mr. Jeremy Wright, Student Services Director, for his help in securing this grant. Dr. Williams also noted that he was able to attend the Robotics Camp at the NC School of Science of Math in Raleigh, during July. Some high school students were able to attend the two-week camp, along with their chaperones. Dr. Williams was very impressed with the program.

During the Report from the Board, Mr. Felton commented on the dedication of teachers. Dr. Dickerson said he was impressed with the information provided at the meeting. He feels like our principals and teachers are making things happen.

Mr. Rube Blanchard, Finance Officer, reported that new budget codes are being set up. The initial State Allotment is pretty much the same as last year. There have been increases in retirement and health insurance costs. The Daycare July assessment is not complete, and will be presented at the next meeting.

There being no further business, Mrs. Boone made a motion to reconvene to Closed Session. Dr. Dickerson seconded the motion, and the board members approved the motion unanimously. Chairman Felton recessed the session to reconvene to closed session at 11:45 a.m.

At the conclusion of the closed session, Mrs. Boone made a motion to recess until Friday, August 10, 2018, whereby the board would reconvene at 441 Taylor Mill Road, Eure, NC, beginning at 10:00 a.m. Mrs. Whitehurst seconded the motion, and the board members approved the motion unanimously. Chairman Felton recessed the session at 1:15 p.m.

The Gates County Board of Education returned from recess and met in regular session on Friday August 10, 2018, at 441 Taylor Mill Road Eure, NC 27935. Chairman Felton called the meeting

to order at 10:00 a.m., with the following board members present: Mr. Ray Felton, (Chair), Mrs. Claire Whitehurst, Mr. Leslie Byrum and Mrs. Glendale Boone. Mrs. Glendale Boone made a motion to re-enter closed session and Mr. Leslie Byrum seconded the motion to discuss matters that are confidential by law, including confidential student matters, pursuant to North Carolina General Statute 143-318.11(a)(1); to confer with the Board Attorney and preserve the attorney/client privilege as allowed by North Carolina General Statute 143-318.11(a)(3); and to discuss personnel as allowed by North Carolina General Statute 143-318.11(a)(6). There was no discussion and the motion carried unanimously.

Mr. Felton reconvened the business session at 10:05 a.m.

Mr. John Greene, Maintenance Director, discussed the pros and cons of the lawn care this past year. He is proposing for 2018-2019 that the Maintenance Department be responsible for lawn maintenance at the Bus Garage, Maintenance Building, the Central Office and Gatesville Elementary School. Brinkley's would be responsible for all other campuses. Mr. Byrum cautioned against exceeding payment of \$50,000 for Brinkley's, to avoid possible lawsuit. Mrs. Boone suggested adding more specific requirements, such as necessary equipment and minimum number of employees. The current contract is less than \$50,000.00. If extra work is needed, such as ballfield prep/landscaping or snow removal, etc.; this could be discussed. However, we need to be careful not to exceed \$50,000. Mrs. Boone made a motion to approve Brinkley's Lawn Care contract for Gates County High School, Central Middle School, T.S. Cooper Elementary School, and Buckland Elementary School, and the Maintenance Department to be responsible for lawn care at the Central Office, Bus Garage, the Maintenance Department and Gatesville Elementary School. Mrs. Whitehurst seconded the motion. Board members approved the motion, with the exception of Mr. Byrum, who voted no. Mr. Byrum stated that he disagreed with the process, and thought the maintenance department should receive additional compensation for added duties. The Board requested a letter to be personally delivered to Lilly Pad.

Mr. Felton discussed the CMS Project and praised Daniel Plyler for his diligent work on the project.

Dr. Williams informed that he had talked with Dr. Mason, with the Economic Improvement Council concerning the increase in building rent from \$350.00 to \$450.00 per month. Dr. Mason did not agree with the increase. The board discussed what steps need to be taken next.

Mr. Rube Blanchard presented the 2018-2019 Budget Resolution.

There was discussion regarding the UNC Dental School Screenings for all Pre-K.

Mrs. Boone made a motion to approve the increase in rent to \$450 for the Head Start Program, approve the 2018-2019 Budget Resolution and approve the Pre-K Dental Screening performed by UNC Dental School. Mr. Byrum seconded the motion, and the board members approved the motion unanimously.
