Board Highlights December 2, 2013

The Gates County Board of Education met to discuss personnel as outlined in N.C. General Statute 143-318.11(a)(6).

The Gates County Board of Education held its regular monthly meeting in the Media Center of Central Middle School on December 2, 2013 at 7:02 p.m.

Chairman G. Douglas Lilley welcomed visitors and staff.

Deborah Byrd addressed the Board during public comment regarding her daughter's absences. Her daughter is a tenth grader at Gates County High School and has unexcused absences for being out sick. Ms. Byrd expressed concern over the fact that students who are absent from school with an illness are not considered excused unless they furnish a doctor's note. She believes this is ridiculous because she doesn't always bring her daughter to the doctor when she is sick. She brought a paper she had gotten signed by forty-five students who claim that they go to school sick in order to avoid unexcused absences. She is asking for a change in this policy to allow absences to be excused with a note from a parent. Mr. Doug Lilley indicated that the Board and Dr. Williams would discuss the matter and respond to her as soon as possible.

Donna Richardson with AdvancED presented a plaque and banner in honor of Gates County Schools' District Accreditation. She commended Gates County Schools for being one of sixty-five schools across the state to receive AdvancED Accreditation. She praised Dr. Williams, Monique Hicks, and Twanna Morales for their commitment and dedication. She also applauded Gates County Schools' conscious efforts to maintain small class sizes.

Morgan Barnes, Student Advisor to the Board, shared the Good News about Gates County Schools.

Central Middle School presented the Academic Report:

*Students handed out ipads and ipods to the board members, Dr. Williams, and other attendees. Participants were then given a sheet of questions dealing with certain academic content areas such as, math, science, history, etc. They all went around the room with their devices and scanned these codes called, "QR" codes which would produce valuable information to aid in answering the questions on the handout they were given. There was an excellent motivational speaker from Real Talk and a speaker from Freedom Writers. There was also a speaker from the State of Florida who had some very good ideas. She is an advocate for Common Core and gave pointers to get parents and community leaders involved. Finally, credit was given to a Vietnam Veteran's speech on leadership.

Mr. Byrum also commended the speakers at the NCSBA Conference as well as Dr. Williams' presentation. He stated that Dr. Williams may be called to the National School Board Conference on April 14, 2014. Mr. Byrum also mentioned the Southern Regional Conference on eBoard that is coming up. Mr. Byrum reflected on a conference he and Mrs. Boone attended where parents of children who perished in the Sandy Hook tragedy are partnering with a company developing software accessible by laptop, phone, and other electronic devices. With this software, electronic devices will be able to access all safety manuals, cameras, first responders, etc.
