Board Highlights May 5, 2014

The Gates County Board of Education met to discuss personnel as outlined in N.C. General Statute 143-318.11(a)(6).

The Gates County Board of Education held its regular monthly meeting in the Conference Room of the Gates County Board of Education Office on May 5, 2014 at 7:06 p.m.

Chairman G. Douglas Lilley welcomed visitors and staff.

Public Comments

Mr. Earl Rountree spoke about Common Core during Public Comment. He made mention of how Common Core will probably be repealed and urged everyone to embrace that idea. Mr. Rountree addressed Mr. Lilley regarding his upcoming departure as school board chair. He expressed his appreciation for Mr. Lilley's devotion and dedication and turned his attention to the other board members to convey his gratitude for their service as well.

Agenda Items

Xavier Roscoe, Student Advisor to the Board, shared the Good News about the Elementary Schools, and Michelle Munoz, Student Advisor to the Board, shared the Good News about the Middle School and the High School.

Lori Ward, Director of the Pre-K Program presented the Academic Report. She spoke briefly about how they are preparing for next year and have met with parents and Kindergarten teachers. She then introduced one of the Pre-K teachers, Mrs. Mary Bunch. Mrs. Bunch talked about how NC has updated their foundations and has brought attention to their guidelines showing what they teach their children with regard to Pre-K Standards. The guidelines prepare the students for academics and school readiness. Mrs. Meghan Maurer, a parent of an autistic child who is enrolled in the Pre-K Program at Gatesville Elementary School spoke about her daughter's vast improvement since entering the program over two years ago. She gave boundless credit to the teachers and staff who have worked tirelessly and diligently to ensure her daughter's growth and development. Mrs. Maurer was asked if there was anything she would change about the program if she could, and she did mention how difficult the program is to get into with the strict income and disability requirements. Mrs. Lori Ward showed a PowerPoint of parents giving their commendation to the Pre-

K Program and to the teachers and staff who make it such a success.

Mrs. Lori Ward asked the board members to participate in a "Jeopardy" type game with handouts they received.

Dr. Williams sent a letter to Mrs. Michele Warren, Family and Consumer Science teacher in the Career and Technical Education Department at Gates County High School, detailing Alyssa's day in the life of a superintendent.

During the Report from the Board, Mr. Felton stated that Relay for Life was a bust due to the weather, but he was thrilled to see the award the school got that was handed out. He was able to speak with Amanda Hobbs's class about cancer and Relay for Life and got the student's attention by telling them that about one third of them would end up getting cancer. He went on to praise the school system's participation in Relay for Life and commended the willingness of students, teachers, and staff to help.

Mrs. Whitehurst helped judge the Science Fair at Buckland Elementary and she thought the projects were really wonderful. Mrs. Whitehurst was able to attend the Prom and the Viking Ball and spoke about how beautiful the decorations were and how lovely all the students looked dressed up.

Mr. Lilley and Dr. Williams met with Commissioner Chairman Dr. Henry Jordan and Interim County Manager, Ed Windley at the Central Office to go over the budget. Mr. Lilley said the meeting was very beneficial and enlightened Dr. Jordan and Mr. Windley to the essential needs of the schools. Dr. Jordan said he was very impressed and commented that this is the first time his eyes were opened to the needs of the school system. It was an excellent meeting and Dr. Jordan and Mr. Windley seemed very receptive to what was presented.

Mr. Byrum was disappointed that he was unable to attend the Prom or the Viking Ball. He has had a rough time with health related issues this year. He did mention Common Core and how he doesn't think DPI did a good thing by selling it to the school systems here. Mr. Byrum believes that if Common Core went back to the way it was originally, it would be much better. The legislators are in the same position, yet are dictating doing away with tenure. Mr. Byrum feels that the morale is low due to all of this.
