# Board Highlights June 3, 2015

The Gates County Board of Education met in regular session on Wednesday, June 3, 2015 at the Performing Arts Building at Gates County High School. Madam Chair Glendale Boone called the meeting to order at 7:25 p.m., and welcomed visitors and staff.

Mrs. Linda Hobbs, former Director of Exceptional Children for Gates County, spoke about the importance of keeping the daycare open. She wrote the grant for this program fourteen years ago and feels it has been a great asset to the county.
