Board Meeting Highlights April 4, 2016

The Gates County Board of Education met in regular session on Monday April 4, 2016, in the cafeteria at Central Middle School. Prior to the meeting being called to order Madam Chair Glendale Boone read the following statement "The board understands many of you have had some very sincere concerns regarding a perception of a lack of communication and support, however, the board individually and collectively supports you and your efforts to educate our children and sincerely appreciates every effort you make to afford our children the best educational experience possible." Madam Chair Boone then called the meeting to order at 7:02 p.m. The following board members were present: Glendale Boone, Ray Felton, Leslie Byrum, Claire Whitehurst and Dr. Daniel Dickerson.

Mrs. Whitehurst made a motion to approve the agenda. Mr. Byrum seconded the motion, and the board members approved the motion unanimously.

There was a moment of silence followed by the Pledge to the American Flag.

Mrs. Sherl W. Lowe signed up for public comments. Mrs. Lowe is a retired Gates County Schools teacher, and is now employed as a tutor and substitute teacher in our school system. She voiced her concerns as a Gates County citizen, and as a grandparent of children who will be entering the school system. She made a heartfelt plea for the board to consider staffing needs when they look at the budget for the 2016-17 school year. With her duties at Buckland Elementary School, she has been able to witness firsthand how the elimination of positions has greatly impacted the daily requirements needed to teach our children. She thanked the board for the job they are doing, and encouraged them to keep fighting for our schools.

Mrs. Chante' Jordan, interim principal at Central Middle School, presented a video of her staff and students, highlighting student activities. Some of the staff were present for the meeting, and Mrs. Jordan asked them to introduce themselves.

Student Advisors Deja Gainey and Jay Brooks presented a powerpoint with Good News from the schools.

Dr. Williams asked that the agenda be amended to add Item No. Fifteen – Petition For Election To Replace Central Middle School. A copy is attached and made part of these minutes.

During the Superintendent's Report Mrs. Tammi Ward, principal at Gates County High School, presented information regarding the HOSA State Leadership Conference held last week. The GCHS HOSA Club won five awards for community and service recognition:

Alzheimer's North Carolina Assoc. North Carolina HOSA State Service Project Leukemia/Lymphoma HOSA National Service Project Prevent Blindness of North Carolina Service Project American Red Cross Outstanding Recognition Award

Our school was also one of 24 high schools/colleges from across the state to receive the prestigious Gold Star Chapter Awards, and this is the fifth year that the GCHS HOSA Club has won this award.

There were over 2,000 participants attending this state leadership conference.

Christa Bazemore- won with outstanding knowledge testing, speech, and interview for the District 1 NC HOSA Executive Council. She will represent our school and state also at nationals as a HOSA State Officer. She will begin leadership training in May.

Lisa Ward, RN, HOSA Advisor was also awarded one of the 21 Gold Star Advisor Awards given out to outstanding HOSA Advisors from across the state. She then went on to receive the highest advisor award for HOSA and was named as the North Carolina HOSA ADVISOR OF THE YEAR for 2015-2016. She will also continue to serve on the NC HOSA Board of Directors for next school year and will represent our state at the International HOSA Conference in Nashville, Tennessee this summer.

Mrs. Tammi Ward congratulated Mrs. Lisa Ward, and her students, for a job well-done.

Mrs. Ward also congratulated Jay Brooks, who has been accepted to attend Governor's School, and Deja Gainey, for participating in the Habitat for Humanity project.

During the Report from the Board, Mrs. Whitehurst said that she had attended the Fairytale Courtroom play, presented by the Drama Club at Gates County High School, and thoroughly enjoyed the presentation. She and Mr. Byrum attended the NCSBA Spring Law Conference and were given a lot of helpful information.

Mrs. Boone read a letter from Krystle Williams and Whitney Farmer, 7th Grade Language Arts Teachers at Central Middle School. They shared, that through DonorsChoose.org, they received donations that allowed them to purchase 30 Chromebook computers for their students to use in the classroom. They gave a special thank-you to the businesses and individuals that made this possible.

Mrs. Tammy Boone, Chief Academic Officer/Federal Programs, provided information that she had learned at a meeting in March, regarding the Every Student Succeeds Act. The president signed this bill into law on December 10, 2016. There are still a lot of unanswered questions regarding the implementation of this law, but the state is starting the process of formulating a plan. Mrs. Boone encouraged everyone to voice their recommendations by visiting the Department of Public Instruction website, and go to the "Let's Talk" section to enter suggestions. It is critical that we voice our recommendations as soon as possible, since this program will be implemented with the 2017-18 school year.

Mr. Rube Blanchard gave the Financial Report for month eight, and gave a financial update on the New Beginnings Daycare.
