Board Meeting Highlights Regular Session October 3, 2016

The Gates County Board of Education met in regular session on Monday, October 3, 2016 at Central Middle School, beginning with closed session at 5:30 p.m. Madam Chair Glendale Boone called the business meeting to order at 7:10 p.m. The following board members were present: Glendale Boone, Ray Felton, Leslie Byrum, Claire Whitehurst and Dr. Daniel Dickerson.

Mr. Byrum made a motion to amend the agenda, by adding Item Number 13 – Budget Amendment Number One – State Funds, to the Consent Agenda, and also adding the discussion of the Gates County Schools Employee Transfer Form to the Unfinished Business Agenda. Mrs. Whitehurst seconded the motion, and the board members approved the motion unanimously.

There was moment of silence followed by the Pledge of Allegiance, led by William Maurer, Central Middle School student.

There were no public comments.

Mrs. Adrienne Bradley, Director of Student Services, introduced Dr. Jared Miller with Sentara Orthopedic and Sports Medicine in Elizabeth City. Dr. Miller spoke about the partnership with Sentara and Gates County Schools, to provide our school system with an athletic trainer. This program will provide our athletic department with a much needed service, to provide care for our injured athletes, especially in the area of concussion management. Up to this point, they have been unable to fill the position, but are actively searching for the most qualified applicant. In the interim, until someone is hired, they are providing services at our games on Friday nights.

During the academic report, Mr. Hunter spoke about the need for a new building to house our middle school students. He also introduced one of the band students from Central Middle, William Maurer, who provided entertainment by playing music, which was enjoyed by all.

Student Advisors Jay Brooks, Dylan Eure, and Chase Evans provided a powerpoint with Good News from the schools.

Dr. Williams provided a power point giving information regarding the condition of the Central Middle School building, and the need for a new school.

Dr. Williams also informed that all five schools had received Green Ribbon Positive Behavior Intervention and Support recognition.

Lola Rountree presented information regarding test scores for Gates County Schools. Our district met the 95% Rule, which requires at least 95% of students be tested. Our schools did very well in comparison with other schools in the area, as reflected in the chart below:
