# Board Meeting Highlights Regular Session February 6, 2017

The Gates County Board of Education met in regular session on Monday, February 6, 2017 at Gatesville Elementary School, beginning with closed session at 5:00 p.m. Chairman Felton called the meeting to order at 6:00 p.m. The following board members were present: Glendale Boone, Leslie Byrum, Dr. Daniel Dickerson, Ray Felton, and Claire Whitehurst.

Mr. Byrum made a motion to amend the agenda to strike through Item number 50 – Approval of Invoice for December Staff Appreciation Banquet. Mrs. Boone seconded the motion, and the board members approved the motion unanimously.

There was a moment of silence followed by the Pledge of Allegiance, led by Kaylee Seward, Gatesville Elementary Student.

Mrs. Barbara Toti, teacher at Gates County High School, spoke during the Public Comments section. She thanked the school system for their support of Special Olympics, especially for the Polar Plunge event in January. She handed out Save the Date cards for the presentation of The Wizard of OZ on March 11<sup>th</sup> and March 12<sup>th</sup>, 2017. This will be the 100<sup>th</sup> production at Gates County High School. Mr. Felton thanked Mrs. Toti for her dedication.

Student Advisor Dylan Eure provided a powerpoint with Good News from the schools. It was noted, by the board, that Dylan had competed for office at the State Beta Convention, and that Gates County High won many awards. Jay Brooks, student advisor, has been accepted at West Point Academy.

During the Academic Report, Mr. Corrente, Principal at Gatesville Elementary, gave highlights of events at their school. Suzanne Newbern, Dance Teacher at Gatesville Elementary, informed about the bulletin board showcasing creative ways students are expressing "It's Great To Be A Dragon". Zamaria Kinsley, Annabelle Sadler and Emily Seward shared their thoughts. Mrs. Robin Brown's 5th grade students at Gatesville Elementary used their knowledge and resources to build a roller coaster while studying force and motion. Partnering with Ms. Keli Boone, 4H agent for Gates County NC Cooperative Extension office, the students studied how speed, acceleration, height, stability, and friction all play a part in building various roller coasters that included ski jumps, hills, valleys, hoops, and spirals out of pipe insulation, tape, blocks, boxes, cups, binders etc. Dr. Williams and Mr. Felton had the pleasure of sending the marbles down the tracks during the presentation.
